Acknowledgment and Assumption of Risk

I acknowledge that by signing this document, I am releasing A Sacred Place, and their respective owners, agents, employees, members, sponsors, promoters, partners, officers, Directors, staff, and affiliates (collectively "Releasee's") from liability. This release form is a contract with legal consequences. I have been advised to read it carefully before signing. This Assumption of Risk form is binding for all activities I participate in at 970 NH Route 118, Canaan, NH

Activities covered by this document include: hiking, camping, swimming, participation in rituals, bonfires, campfires, cook fires, cleanups, training and any other recreational, spiritual, or educational program offered

I understand that reasonable steps have been taken to provide a safe and enjoyable environment. I acknowledge that some activities of this event have risks, including certain risks which cannot be eliminated.

I understand that this notice does not want to frighten me or reduce my enthusiasm, but considers it is important for me to know in advance what to expect and to be informed of the certain inherent risks.

The following describes some, but not all, of those risks:

- The site is primitive and does not have cell phone service. In the event of a medical emergency evacuations and medical care may be significantly delayed.
- Environmental risks and hazards include possibly rapidly moving, deep or cold water; insects, snakes, large and small wild animals. There have been cases of rabies in animals in the area.
- Unpredictable forces of nature, including weather which may change to extreme conditions without notice. Possible injuries and illnesses include hypothermia, sunburn, heatstroke, dehydration, and other mild or serious conditions.
- There will be campfires, and cook and community fires about the event area that may pose a serious risk of injury

I understand the description above of these risks is not complete and that other unknown or unanticipated risks may result in property loss, injury or death. I agree to assume responsibility for the inherent risks identified herein and those inherent risks not specifically identified. I am attending of my own free will; I elect to participate in spite of and in full knowledge of the inherent risks.

I acknowledge that by attending this event that I have responsibilities as a participant and/or as a guardian of minor children.

I represent that I am fully capable of participating in the program, without causing harm to others or myself.

I have no physical or medical condition which to my knowledge, would endanger myself or others, or would interfere with my ability to participate in this event.

I agree it is my sole responsibility to be familiar with these and Festival Rules, and any special regulations for the event.

I understand and agree that situations may arise during the event which may be beyond the immediate control of the Releasee's. I will follow the instruction and guidance of the staff and organizers.

I agree, for myself and my successors, that the above representations are contractually binding, and are not mere recitals, and that should I or my successors assert my claim in contravention of this agreement, the asserting party shall be liable for the expenses (including legal fees) incurred by the other party or parties in defending, unless the other party or parties are finally adjudged liable on such claim for willful and wanton negligence. This agreement may not be modified orally, and a waiver of any provision shall not be construed as a modification of any other provision herein or as consent to any other provision herein or as consent to any subsequent waiver or modification.

Every term and provision of this agreement is intended to be severable. If any one or more of them is found to be unenforceable or invalid, that shall not affect the other terms and provisions, which shall remain binding and enforceable.

This agreement is entered into voluntarily, after careful consideration and is binding upon the persons signing below, their heirs, executors, administrators, wards, minor children and other family members.

Therefore I, assume and accept full responsibility for myself and minor children, if any listed below, for injury, death and loss of personal property and expenses suffered by me and them as a result of those inherent risks and dangers identified herein, those inherent risks and dangers not specifically identified, and as a result of my negligence or otherwise wrongful conduct in participating in these activities.

For myself, my heirs, executors, administrators, legal representatives, assignees, and successors in interest (collectively "Successors") **I HEREBY WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS, AND PROMISE TO INDEMNIFY AND NOT TO SUE** the Releasee's and the sponsors of this event, the organizer and any promoting organizations, property owners, law enforcement agencies, all public entities, special districts and properties, and their respective agents, officials, and employees through or by which the events will be held, (the foregoing are also collectively deemed to be Releasee's), **FROM ANY** and all rights and **CLAIMS INCLUDING CLAIMS ARISING FROM THE RELEASEES' OWN NEGLIGENCE**, which I have or which may hereafter accrue to me and from any and all damages which may be sustained by me directly or indirectly in connection with, or arising out of, my participation in or association with the event, or travel to or return from the event.
